

Elevating Education Contest

Fill out the nomination form in its entirety on <https://info.altafiber.com/elevate-education-contest> indicating why a local school you are nominating deserves a technology upgrade valued at \$20,000.

Official Rules

- Winner of the “Elevating Education Contest” will be determined by altafiber and based on the “quality” of nomination(s) the school receives. Participation is open to any school within the altafiber operating area in Ohio, Kentucky and Indiana, that receives and accepts a nomination by 11:59 p.m. ET on April 1, 2023.
- The nominating individual will not win any individual prize, only the winning local school nominated is eligible to win \$20,000 in technology value to be used within the school, specifically for the purpose of elevating access to educational opportunities for the students.
- Nominees will be notified that they have been nominated and will be given a chance to withdraw from consideration. The components of the \$20,000 technology upgrade will be mutually agreed upon by altafiber and the administrative team of the winning school, and may include items up to and including: high-speed internet, communication or wi-fi services from altafiber, hardware, equipment, tablets, laptops, mobile devices and/or accessories.
- Contest is subject to all applicable federal, state, and local laws. Contest sponsored by Cincinnati Bell, Inc. dba altafiber or “Sponsor”, headquartered at 221 East Fourth Street, Cincinnati, OH 45202.
- Contest is open to schools located in Cincinnati Bell’s operating area in Ohio, Kentucky, or Indiana as of the date of entry. Void where prohibited. How to Enter

- Nominate a local school via the form on <https://info.altafiber.com/elevate-education-contest> in order to enter that school in the contest. **School must be within altafiber's operating area.**
- The winner will be selected by a Panel of altafiber employees in its sole discretion. The Panel will evaluate all valid nominations and select the winner from all eligible nominations. Submissions will be judged based on the following criteria of "quality": (1) Emotional Value and (2) Creativity.

Duration

- The Elevating Education Contest will begin on February 22, 2023 at 11:59am and end at 11:59 p.m. ET on April 1, 2023. All nominations must be completed by the end date in order to be considered.

Publicity / Privacy

All entries become the sole property of altafiber. By accepting a prize, winner agrees to altafiber's use of its name and the names, voice and/or likeness of its designated representative(s), without further compensation.

Prizes and Values

(1) Upon acceptance of the prize, Winner will receive a technology upgrade for the school valued at \$20,000.

- No cash or other substitution or transfer of prize permitted, except that altafiber, reserves the right to substitute a prize with another prize of greater or comparable value.

Winners

Winning a prize is contingent upon being compliant with these Official Rules and fulfilling all other requirements set forth in these Official Rules.

Winner will be required to sign an Acceptance Agreement specifying terms and conditions of acceptance which include but are not limited to limitations of liability, release of claims, dispute resolution, indemnification etc.

Taxes

- Winner is solely responsible for reporting and paying any and all applicable federal, state, or local taxes.

All decisions are at the sole discretion of the Sponsor. If for some reason the winner does not accept the prize, Sponsor reserves the right to select a substitute winner in its sole discretion.”
