

Nothin' but Local OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

ELIGIBILITY: Nothin' but Local ("Sweepstakes") begins on March 18 at 9am ET Standard Time ("EST") and ends on Monday, April 7 at 11:59PM EST ("Sweepstakes Period"). The time shall be determined by Sponsor's timekeeping systems, and Sponsor may also rely on the time processing functions of third parties.
